## John Barker Place Redevelopment Resident Newsletter

We'd like to welcome you to the third issue of our Autumn newsletter with an update on the progress of works being carried out on the development of Phase 2 at John Barker Place.

#### **Progress & Upcoming Works**

- You will have seen a mobile crane on site during September and this will be in place throughout October to enable Lovell to install the remaining blocks.
- From Monday 30th September there will be a road closure for three weeks. This is to facilitate the completion of the drainage connections on Westmill Road and to then complete the resurfacing works to the area. Due to safety reasons, there will be no access behind the block of 14-19 Michael Muir House.
- From Monday 14th October we will be carrying out section 278\* works to the two front entrances to the site including works to the 2 bell mouths (2 entrances to the site) During this time the parking bays to the front of the construction site will be temporarily suspended. We aim to complete these works promptly, we apologies in advance for any inconvenience this may cause.
- Hoarding removal will commence a week before the 278 works start, this is to facilitate the works we need to complete to the front of the site.
- Lift installations have commenced and will be completed by December 2024.
- Internal works have progressed well, with final and decorating works remaining in properties.
- Target completion is due January 2025.

Section 278\* allows developers to enter into a legal agreement with the Council, to make alterations and improvements to a public highway, as part of a planning application.

**Protecting our environment**-This Quarter we have achieved a 99.7% diversion from landfill rate. This means 99.7% of waste produced on this site has been recovered, recycled or converted to energy. utility procedures regularly. All lights in our cabins are motion activated to eliminate light use out of hours and our bathrooms fit with water saving devices such as dual flush toilets and low-pressure taps.

We are delighted to have joined up with The Pallet Loop to help us enforce our commitment to protect the environment and contribute to the circular economy by reducing pallet waste. The Pallet Loop discards the familiar linear practice of 'deliver, distribute and discard' in favour of the more sustainable model of 'recover, repair and reuse to eliminate avoidable pallet waste. So far, we have returned 60 pallets to Pallet loop saving the equivalent of



300CO2e/Kg.
